



FRENCH CULINARY TOUR – SEPTEMBER 2012 - TERMS AND CONDITIONS

RESERVATIONS:

A non-refundable deposit of \$995 per person is due to reserve your space. Final payment is due no later than June 13, 2012 (90 days before tour starts). If final payment is not received by June 13, 2012, Ma Belle France reserves the right to consider the booking as cancelled by you and levy cancellation charges unless alternative arrangements have been made. Please note that this trip has a limited availability and reservations will be held on a first come basis.

RATES:

All rates are based on value of Euro currency at the time of October 15, 2011 and are subject to change. Ma Belle France will do the utmost to keep prices as published. Should increases be forced upon them they reserve the right to surcharge a fee of up to a maximum of 10% of tour cost.

INCLUDED:

Accommodations, all meals, cooking classes fees, hotel taxes and service fees, all excursions and visits, and local transportation in Paris and in Normandy.

NOT INCLUDED:

Airfare to Paris, R/T transfers between airport and hotel in Paris, beverages of any kind, and items of a personal nature such as laundry, telephone calls, passport fees (if applicable), tips to drivers, guides, travel insurance, etc.

TRAVEL INSURANCE:

We strongly recommend the purchase of travel insurance as additional security in the case of cancellation or interruption of travel plans, lost or damaged luggage, travel delays, illness, or accident. Ma Belle France strongly suggests you obtain travel insurance with Travel Guard International at 800-549-9037 or www.TravelGuard.com.

CANCELLATION:

- Administrative fee of \$500 per person is non-refundable.
- If cancellation occurs 74 to 45 days prior to departure, you would lose \$1,500 per person cancellation fee plus any non-refundable pre-paid expenses and administrative fees.
- If cancellation occurs 44 days or less prior to departure, registrant will be considered a "no show" resulting in forfeiture of all monies paid.
- All cancellations must be made in writing to Ma Belle France, 32 Meadowview Road, Asheville, NC 28804, or by email to admin@mabellefrance.com. . Cancellations will not be accepted by telephone.

The dated letter or e-mail will calculate cancellation penalties. Refunds due will be processed 6-8 weeks from date of the arrival of cancellation letter.

CHANGE FEES:

Once you reserve your tour, changes from double to single occupancy are possible according to availability. Changes are to be made in writing and a revised invoice will be sent to you for the additional charges. No changes will be made without written

consent and authorized payment. If you make roommate changes during your trip you will be responsible for the payment of your single/double room fee as well as the single/double fee for your original roommate. Any voluntary changes made throughout your stay in France will be charged to your credit card on file with Ma Belle France immediately.

RESPONSIBILITY:

Reservation of Right to Decline Reservations and Right to Terminate: Ma Belle France hereby reserves the right to decline to accept reservations for this tour for any reason in their sole discretion. In the event a reservation is accepted, Ma Belle France further reserves the right to terminate any participant (or any member of his/her family) from the tour and its attended activities in the event any participant is declared to be disruptive to the group or others at any time during the tour. In the event that any participant (or any member of his/her family) is terminated for the reasons listed above, it is expressly understood that the participant (or any member of his/her family) will not be refunded any monies that have previously been paid for the remainder of the trip. By your signature below, you agree that in the event of a termination of you or any member of your family, Ma Belle France will NOT be responsible for your accommodations and/or your transportation for the remainder of the trip, and the monies previously paid for same will not be refunded. Ma Belle France does not own, manage, or operate any hotel, restaurant, or any other supplier of services in France. All coupons, receipts and tickets (if applicable) issued are subject to the Terms & Conditions specified by the suppliers. By signing below, you acknowledge that Ma Belle France will not be liable for any loss, injury or damage to you, your belongings or in connection with any accommodations, services resulting directly or indirectly from any occurrences beyond its control including breakdown of equipment, strikes, delay or cancellation of changes to scheduled services. All accommodations, services and facilities are subject to the laws and the customs of France. Ma Belle France reserves the right to make necessary changes in the itinerary and or services, to substitute accommodations at its own discretion. If cancellation of the tour is made by Ma Belle France, the sole liability of Ma Belle France towards the client shall be a refund.
